1. Introduction

Nation Finance is dedicated to levelling the playing field for traders in decentralised finance by establishing a top-notch trading school to train new traders and examine the market as a whole for valuable signals. The long term project has plans to develop a Dapp, a peer-to-peer trading platform & card payment facilities for both fiat and cryptocurrency.

2. About Nation Finance

Nation finance is a unique deflationary token launched on 26th July 2023 to bring crypto traders, signal users and providers, forex and stock market traders for education and more trading enlightenment and exposition.

Nation Finance is a Defi and will eventually include launchpad and staking into its ecosystem.

Nation Finance is backed up by Highnation Trading community popularly known as Highnation of wall street. Highnation of wall street is a hub for trading knowledge where crypto, forex and stock market traders meet to discuss and analyze the market.

2.1 Solutions Brought By Nation Finance

Nation Finance will allow users to access an ecosystem of Nfts and Gamefi all directly powered by their original NF tokens.

Nation Finance token will bridge to ethereum blockchain and some additional blockchains over the years. The main goal of Nation Finance is to increase the community utility of Highnation Brand and it's ecosystem by creating and adding much needed utility. Nation Finance users can achieve this goal by merely wrapping their NF Tokens into Nation Finance smart contract and receiving NFDAO tokens in return.

Potential Use Cases Include:

- Participating in the Nft Market through minting and exchanging NFTs by paying for gas fees with Nation Finance.
- Partaking in lucrative Gamefi opportunities and engaging with the growing blockchain gaming community.
- Joining decentralized exchanges to swap tokens and speculate on their value.

- Accessing advanced financial instruments such as staking contract.
- Taking part in the upcoming metaverse-powered NFTs.
- Participating in DAOs and funding entire communities.

3. Nation Finance Contract

The Nation Finance project anchors two major contracts namely; Governance Contract and staking Contract.

3.1 Governance Contract

Manages validators proposals and votes. Those are NF DAO members.

3.2 Staking Contract

Manages staking operations and the distribution of token rewards.

4. Potential Applications of Nation Finance

The Nation Finance project will continue to expand its utility by collaborating with industry leading platforms and the potential expanding into Gamefi, Nfts & Defi which we will elaborate on the applications.

4.1 NFT

Nation Finance will provide its users with the capability to publish their own NFTs following the ERC721 Protocol or on partnership over the years.

Since this proven NFT standard is widely accepted by market places and metaverses, **NF NFT** owners will be able to integrate their NFTs into the existing NFT landscape.

4.2 DeFi

Nation Finance will equally serve a **Defi** capable cryptocurrency that can be locked in various liquidity pools and provide rewards to holders over time.

They will be enabled to use for lending when the prop firm lending program starts increasing the utility of the project.

4.3 GameFi

Nation Finance will expand to the gameverse where NF built games can be downloaded and played while **NF Tokens** will serve as gas fee and valuable price.

As a result of that NF assets will enable users to participate in virtual gaming economies and share digital resources in their favorite gameverse.

5. Tokenomics

Total supply: 250 million

Initial Burn: 1% per transaction

Circulating Supply: 250 million

Liquidity pool: 1 year locked to be extended

to forever locked in 2026

Ownership: Renounced

5.1 Burning Mechanism

Nation Finance Token burns per transaction and has a 5% transaction fee which is split into:

1% burn 2% marketing 2% liquidity

These covers for the development of the project.

6. Nation Finance DAO

Nation Finance as a decentralized autonomous organization (DAO) is a management structure that uses blockchain technology to automate some decision making like voting and transaction processing.

DAOs are a key component of important blockchain applications including cryptocurrency as well as Web 3, a proposed architecture for the next generation of the web that relies on the decentralization enabled by blockchain.

NF DAO is the governance token of the Nation Finance ecosystem, NF DAO is creating a robust structure that will bring several global enthusiasts together to actualize great and unimaginable ideas for the ecosystem.

NF DAO Token Distrubution:

• Total Supply : 300,000

• Liquidity & listing: 15%

• Presale : **5**%

• DAO Fund : 12%

• Development Fund : 10%

Gamfi & NFt Foundation: 10%

• Treasury : **7**%

Airdrop will be in ratio 1:20, as part of our long-term strategy to reward NF DAO Members for holding Nation Finance consistently, we have decided that further release of NF DAO tokens into circulation will be done by NF DAO members after NF DAO launching our DAO platform. Every DAO member is given the power to claim certain amount of NF DAO token monthly.
